- \_\_\_\_\_ **120 (4-6):** 120cc stock sleds, riders ages 4-6
- \_\_\_\_\_ **120 (7-12):** 120cc stock sleds, riders ages 7-12
- \_\_\_\_\_ **120 Champ/Open:** 120cc open mod sleds, riders ages 4-12
- \_\_\_\_\_ **Transition 8-12:** 300cc Ski-Doo Freestyle or 500cc Arctic Cat Sno Pro with 50% throttle limiter & restricted ECU, riders ages 8-12
- \_\_\_\_\_ **Junior Novice:** Up to 600cc fan or free air or 500cc Arctic Cat Sno Pro with 50% throttle limiter, riders ages 10-14
- \_\_\_\_\_ **Junior:** Up to 600cc liquid or any fan cooled sled up to 600cc, riders ages 13-17
- \_\_\_\_\_ **Junior Girls:** Any production snowmobile, open displacement, riders ages 13-17. Minimum of three riders.

#### VINTAGE / TRAIL CLASSES

- \_\_\_\_\_ **Leaf Spring Fan:** Any production leaf spring sled which is fan cooled or free air.
- \_\_\_\_\_ **Leaf Spring Open:** Any production leaf spring sled, open engine displacement.
- \_\_\_\_\_ **Vintage 1995:** Any production snowmobile produced in or before 1995, open engine displacement.
- \_\_\_\_\_ **Ditch Banger:** Any production consumer trail snowmobile, open displacement. No purpose-built snocross race sleds allowed.
- \_\_\_\_\_ **Plus 30:** Any production snowmobile up to 600cc

#### SNOCROSS CLASSES

- \_\_\_\_\_ **Novice 600:** For beginning racers only! For 1<sup>st</sup> or 2<sup>nd</sup> time riders, youth riders, old timers, etc. Not for rides who compete on a regular basis at a regional/national level. Open to liquid cooled sleds up to 600cc.
- \_\_\_\_\_ **Sport 600:** Up to 600cc liquid cooled or 1050cc 4-stroke.
- \_\_\_\_\_ **Sport Open:** Open displacement 2-stroke or 4-stroke.
- \_\_\_\_\_ **Pro-Lite Super Stock:** Up to 600cc stock or 1050 4-stroke. 75% payback, minimum of three riders required.
- \_\_\_\_\_ **Pro Open:** Open displacement 2-stroke or 4-stroke. 75% payback, minimum of three riders required.

**RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT**

In consideration of being permitted to compete, officiate, observe, work for, or participate in any way in the event(s) or being permitted to enter for any purpose any restricted area (defined as any area requiring special authorization, credentials, or permission to enter or any area to which admission by the general public is restricted or prohibited), each of the undersigned, for him/herself legal representatives, heirs, and next of kin:

1. Acknowledges, agrees, and represents that he/she has or will immediately upon entering any of such restricted areas, and will continuously thereafter, inspect the restricted areas, which he/she enters, and he/she further agrees and warrants that, if at any time he/she is in or about restricted areas, and he/she feels anything to be unsafe, he/she will immediately advise the officials of such and if necessary, will leave the restricted areas and/or refuse to participate further in the event(s).
2. Hereby releases, waives, discharges, and covenants not to sue ERX, or the promoters, participants, racing associations, sanctioning organizations, or any subdivision thereof, track operators, track owners, officials, drivers, pit crews, rescue personnel, any persons in any restricted area, promoters, sponsors, advertisers, owners and lessees of premises used to conduct the event(s), premises and event inspectors, surveyors, underwriters, consultants, and others who give recommendations, directions or instructions or engage in risk evaluation or loss control activities regarding the premises or event(s) and each of them, their directors, officers, agents and employees, all for the purposes herein referred to as "Releasees" from all liability to the undersigned, his legal representatives, assigns, heirs, and next of kin for any and all loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned arising out of or related to the event(s), whether caused by any partial or sole negligence of the Releasees or otherwise.
3. Hereby agrees to indemnify and save and hold harmless the Releasees and each of them from any loss, liability, damage, or cost they may incur arising out of or related to the event(s) whether caused by any partial or sole negligence of the Releasees or otherwise.
4. Hereby assumes full responsibility for any risk of bodily injury, death or property damage arising out of or related to the event(s), whether caused by the partial or sole negligence of Releasees or otherwise.
5. Hereby acknowledges that the activities of the event(s) are very dangerous and involve the risk of serious injury and/or death and/or property damage. Each of the undersigned, also expressly acknowledges that injuries received may be compounded or increased by negligent rescue operations or procedures of the Releasees.
6. Hereby agrees that this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of partial or sole negligence by the Releasees, including negligent rescue operations and is intended to be as broad and inclusive as is permitted by the laws of the Province or State in which the Event(s) is/are conducted and that if any portion thereof is held invalid. It is agreed that the balance shall; notwithstanding, continue in full legal force and effect.

Hereby agrees that photographs, video productions and telecasts may be made of the undersigned either alone or together with others, during the race event or at such times or places as ERX and or an ERX affiliate shall designate. The undersigned agrees that all rights in such photographs, video productions and telecasts including, but not limited to, rights of sale, reproduction, use and distribution, shall belong to ERX and or an ERX affiliate, its successors or assigns. ERX may make whatever use of such photographs, video productions and telecasts as it or they may desire. The undersigned hereby grants to ERX and or an ERX affiliate, its successors and assigns, the non-exclusive right to use the undersigned's name or likeness for any and all commercial benefit and purpose, without limitation, in perpetuity, throughout the universe, in all media.

Hereby agrees to Indemnify and hold harmless ERX and or an ERX affiliate, and their respective directors, agents, licensees, employees, successors and assigns from and against all claims, liability, loss or expense, including reasonable attorney's fees, which may result from the use of the above.
